Chair's Report (Ryan)

. Five years of work on the Board of Directors with a focus on professionalization and organization building: launch of a bilingual website, launch of an awards program, move to national banking platform, efforts to move to membership management software, incorporation of the SSA into a legal entity (with board insurance).

. Ricky Varghese taking over as chair of the Association.

Report from the Vice-Chair and Incoming Chair (Ricky)

- . Thanks to Ryan for his work for the Association over the past five years.
- . Ricky expresses a wish for greater diversity within the Association, and for opportunities to welcome sexuality scholars working outside of Canada.
- . Ricky won't be affiliated with an institution as of September (when postdoc at TMU ends).

Treasurer's Report (Patrick)

- . Budget is stable and sustainable around \$30,000. Expenses are roughly the same as income.
- . Increase in membership this year.
- . Major expenses: legal fees for incorporation as nonprofit, 519 space, keynote honoraria, conference management tool, fees for Federation, emerging scholar award, web hosting
- . Recommendations: payment processing system so members can use credit cards, keep Interac etransfer, close PayPal account when possible, keep an eye on expenses versus income.

Secretary's Report (Suzanne), relayed by Ryan

. Developed a calendar with annual tasks, reviewed and refined list of annual change over tasks, lead the process for moving forward with a payment processor and MMS.

Membership Coordinator's Report (Islandia), relayed by Ryan

- . Association membership has bounced back from low membership after two years of virtual conferences, total of 81 members.
- . Members primarily Canadian, with a small contingent of international scholars from North America, Europe, and Australia.
- . Institutional Sponsors down slightly.

Program's Coordinator Report (Gary)

- . Gary expresses gratitude to the Program Committee.
- . Total of 88 participants in the SSA program this year: 13 panels, 3 roundtable discussions, 2 plenary panels, 1 keynote event (the only off-campus event this year).
- . Issue of bilingualism at SSA and structural inability to support Francophone presenters.
- . Program Coordinator position idea, with "onboarding" structure.
- . JT raises a few points regarding bilingualism: planning the translation work (budget, timeline), designating a coordinator of French-language programming who could engage in outreach with scholars in various provinces, including Quebec.

- . NKT volunteers as area coordinator for 2023 and proposes targeted invitations, considering that Montreal universities are not integrated, language-wise.
- . Cornel proposes bilingual panels, and reaching out to specific senior faculty members.
- . Ryan denounces full-time faculty members who shows up to their own panel and then leave.
- . Melanie proposes a sit-down breakfast or lunch with mentors, or pairing mentors with mentees.
- . NKT suggests an outreach taskforce to facilitate conversations with established scholars.

. Twitter and Facebook reactivated this year, migration to MailChimp mailing list with close to 600 contacts, average of 5,000 website visits a year
